Previously, he was a research and teaching assistant at the Universitat Autònoma de Barcelona and the Institut d'Anàlisi Econòmica (IAE), where he taught several courses on microeconomics, industrial organization, and econometrics. Mr. Álvarez received his MRes in economic analysis from the Universitat Autònoma de Barcelona, and his BSc in economics, *summa cum laude* and ranked 1st, from the Universidad de Vigo.
